- **Please read the entire application; changes have been made to scheduling and payment policy, and umpire information!** Questions may be directed to Village Clerk's Office at [pwinsor@cooperstownny.org](mailto:pwinsor@cooperstownny.org) or 607-547-2411. **By signing this application you agree to all of the terms and conditions of field rental.**
- Any violation of the terms set forth in this contract will result in immediate expulsion from Doubleday Field and possible cancellation of future use. In this event no refund will be given.
- Only baseball/softball teams or groups may use this application to schedule a game. Team practices, modified games, and other events are considered but require special approval from the Doubleday Field Committee and Village of Cooperstown Board of Trustees. Please contact the Clerk's office for more details on how to request a special use.
- **The entire application must be returned. This application serves as a legal document and therefore must remain whole.** In addition, there is pertinent information on both the first and last pages of the application.
- All information is kept strictly confidential and is not shared with any person(s) or organization(s). We respect your privacy. This includes providing information to teams seeking opponents.
- **Field Availability:**
  - ❖ Doubleday Field is available for rental from mid-April thorough Columbus Day weekend. We generally offer 3 games per day at 10 AM, 1:30 PM, & 5 PM. Each time slot is reserved for a single game (7 or 9 innings) not to exceed the 3 hours.
  - ❖ Game/time slots reserved by an applicant are for the use of the teams represented on the application. The applicant may not sublet a time slot.
- **Payment:**
  - ❖ Payment may only be made via check (U.S. banks only) or money order (U.S. bank or U.S./Canadian Postal Service) in U.S. funds payable to "Village of Cooperstown".
  - ❖ Non-refundable deposits and/or application fees must be received with the application.
  - ❖ **Field use fees for teams scheduled to play in April and May must be paid by April 1st. Teams scheduled to play from June through October must make payment by May 1st.**
  - ❖ The team/organization booking Doubleday Field is responsible for sending one check from their organization, in full payment, to the Village of Cooperstown by the deadline stated on the application. We will no longer accept checks from 2 different entities.

➤ **Tournaments:**

- ❖ Tournaments are defined as teams playing at least six games on consecutive days. No tournament may secure the field for more than five consecutive days.
- ❖ Tournaments playing seven inning games may schedule four games per day where games will be played back to back.
- ❖ Organizations may request no more than five tournaments per season unless an exception is granted by the Doubleday Field Committee and the Board of Trustees.
- ❖ A non-refundable deposit of five (5) percent of the total amount of all games requested must accompany all tournament applications.
- ❖ The Village of Cooperstown does not supply, or schedule, umpires! See Page 3 for Umpire Information.

➤ **Individual Games:**

- ❖ Individual games are defined as teams playing less than six consecutive games.
- ❖ A \$25 non-refundable application processing fee must accompany all individual game applications. This fee is not part of the field use fee.
- ❖ The Village of Cooperstown does not supply, or schedule, umpires! See Page 3 for Umpire Information.

➤ **Scheduling:**

- ❖ Applications may be returned as soon as completed. Applications will be processed by the clerk's office in the order they are received.
- ❖ Games will be scheduled and confirmations mailed only after receipt of completed application and payment of tournament deposit or individual game application fee.
- ❖ Tournament applications are mailed on or about October 1 with preferred scheduling until November 15 and notification of acceptance in December.
- ❖ Individual applications are mailed on or about November 15. Notification of acceptance begins in early January.
- ❖ Blank applications will become available at [www.doubledayfield.com](http://www.doubledayfield.com) five days after the mailing of individual applications.
- ❖ The Village of Cooperstown does not provide opponents, only field rental. Renters must arrange for their own opponent. Opponents do not need to supply a certificate of insurance or hold harmless agreement.
- ❖ The Village of Cooperstown Board of Trustees in consultation with the Doubleday Field Committee reserves the right to cancel reservations for any reason, including but not limited to Acts of God, which may interrupt use of the field, with at least 30 days notice whenever possible.

➤ **All applications must be mailed.** Hand-delivery, faxes or emails are not permitted. Applications should be returned to Village of Cooperstown, Doubleday Field Scheduling, 22 Main Street, PO Box 346, Cooperstown, NY 13326.

➤ A Team ID number is issued to each person or organization that applies to use Doubleday Field or has their name placed on our mailing list. This number is assigned by the clerk's office and helps insure that payment and documents are credited to the appropriate team. Once assigned the number will not change unless there is a break of three or more years in your use of the field.

➤ **Fees:**

- ❖ Single games (including doubleheaders)
  - \$25 non-refundable application fee paid when applying for a game
  - Regular Rate (Friday, Saturday, Sunday & Monday) \$500 per game
  - Mid-week (Tuesday, Wednesday & Thursday) & Post Labor Day \$400 per game
- ❖ Tournament Games
  - 5% non-refundable deposit due with application
  - April through Labor Day \$550 per game
  - Post Labor Day Rate \$400 per game

➤ **Required Paperwork:**

- All renters are required to submit a Certificate of Insurance in the amounts of \$2,000,000 General Aggregate, \$1,000,000 Occurrence with the Village of Cooperstown listed as additionally insured, at least 30 days prior to their game. There are no exceptions to the insurance requirement.
- All renters are required to sign and submit to the Village of Cooperstown a Hold Harmless Agreement.
- It is the responsibility of the applicant to complete and return all paperwork. The Village of Cooperstown is under no obligation to contact the applicant regarding incomplete paperwork. Failure to complete the required paperwork will result in cancellation without a refund.
- In order to assure that payment and other requirements are placed with the correct team, please make sure your Team ID number is indicated on all paperwork including payment and Certificate of Insurance.

➤ **Refunds:**

- Applicants who cancel a scheduled time slot(s) ***with at least 60 days written notice*** will receive a ***refund of 90%*** of their field use fees for those time slot(s). No refund will be issued to teams who cancel with less than 60 days written notice, unless the field is re-rented for the same time slot(s); then a refund of 90% of the field use fee will be issued (there are no exceptions to this policy). Should the Village find it necessary to cancel a game due to a situation unrelated to the renter a full refund will be issued.
- Rainouts are determined by the field manager in cooperation with the umpires. If a game is cancelled prior to the completion of the fourth inning a refund will be given in part or whole based on the number of innings played. Rainouts after completion of the fourth inning will not be considered for refunds.
- Refunds are processed once a month and generally mailed the last week of the month following the cancellation.

➤ **Field Rules:**

- Subletting of time slots is not permitted.
- Renters are advised that Doubleday Field is a regulation sized baseball field. No aspects of the field will be altered, including standard baselines of 90', or pitching mound distance.
- Only players and coaches are permitted on the field and in the dugouts. No parents, batboys, batgirls, scorekeepers or photographers are permitted on the field.
- A minimum of nine players are required per team.
- Players must be in uniform to take the field. Street clothes are not permitted.
- All persons from the offensive team must wear a helmet when on the field, including adult base coaches.
- Only one person is permitted on deck, in the batting circle, all other offensive players must be in the dugout. Base coaches must remain in the coach's box.
- Good sportsmanship is expected from all teams and coaches. Use of profanity, throwing of bats, helmets and other equipment, argumentative behavior towards field personnel or umpires or any other unsportsmanlike behavior is not permitted and may result in ejection from the field.
- **The renter is required to use, and pay the fees of certified umpires.** The New York Susquehanna Baseball and Softball Association (NYSBSA) is one organization which provides these services locally. NYSBSA's contact person is Jim Dutcher. He can be reached at 607-282-6021. If you choose to bring your own certified umpires their certifications must be received and approved by the Village Office at least ***30 days prior*** to the game date.
- **If any of your players are under 13 years of age, you will need to provide your own umpires;** and submit their certifications to the Village of Cooperstown, as stated above.
- Village of Cooperstown property is "drug free." The use of any drugs, alcohol or tobacco products is prohibited.
- Due to the residential nature of the surrounding community the use of amplified sound as well as the use of loud music is restricted. The use of the PA system at the field requires a permit and an additional \$100 fee. This permit allows the singing/playing of the National Anthem and the announcement of the starting lineup. Play by play and other uses of the PA system are prohibited.
- In order to assist our staff in maintaining a clean, safe and sanitary environment sunflower seeds and glass containers are not permitted on the field or in the dugouts.
- There is no concession stand at Doubleday Field and the selling of merchandise in the grandstand, on the field or in the parking areas is not permitted. We welcome players and spectators to bring in their own necessary refreshments and ask that they use the disposal containers provided.
- The Doubleday Field manager or designee determines cancellation due to weather, and other related field conditions.
